SUBDIVIDER ESCROW FEE - SALE:

When the owner’s policy of title insurance being issued qualifies for the Subdivider Rate under the title insurance rate schedule, the seller’s portion of the escrow fee shall be reduced to \$250.00. The buyer shall pay their normal escrow fee.

SUBDIVIDER ESCROW FEE - REFINANCE:

When the lender’s policy of title insurance being issued qualifies for the Subdivider Rate under the title insurance rate schedule, the borrower’s escrow fee shall be reduced to \$250.00.

Doc Storage/Security Fee:	\$125 (purchase)
Courtesy Signing: (seller or cash buyer)	\$75
Courtesy Signing: (buyer/borrower with loan docs)	\$150
2 nd loan:	\$200
Sub Escrow:	\$250
Mobile Home Title Elimination (in addition to escrow fee – includes all county and DOL fees)	\$500
Mobile Home in park (in addition to escrow fee – includes all county and DOL fees)	\$650
Mobile home not in park (in addition to escrow fee – includes all County and DOL fees)	\$250
Remote Online Notary – package	\$150
Remote Online Notary – single document	\$50
